The fund will be professionally managed through the First Community Foundation Partnership of Pennsylvania, alongside STEP's Independent Living Endowment Fund, to ensure that assets remain strong over time. The STEP General Endowment will help us bridge those gaps and provide vital services. MIHOPE

Early Learning Pathway to Success



Engagement STEP Early Head Start recently participated in the Mother and Infant Home Visiting Program Evaluation (MIHOPE), the largest and most comprehensive home visiting study ever conducted in the United States. Being deployed across 12 states and 88 sites, the study will assess child and parental outcomes including health, development, parenting skills, school readiness, and academic achievement. The study also will assess the potential of home visitation programs to reduce health care costs. The study's results are expected to be released in 2018. STEP Head Start recruited families who completed a baseline survey and agreed to share additional information and records. They will be followed in the study until their children are 5 years old.
